

# **Mines & Meadows Privacy Policy**

## **Introduction**

MINES & MEADOWS, LLC (hereinafter referred to as MINES & MEADOWS) respects each individual's right to personal privacy. We will collect and use information through our Web site only in the ways disclosed in this statement. This statement applies solely to information collected at MINES & MEADOWS' Web site [minesandmeadows.com](http://minesandmeadows.com).

## **Part I. Information Collection**

MINES & MEADOWS collects information through our Web site at several points. As a general rule, we do not collect personally identifiable information about our site's visitors. However, there are a few instances in which our users voluntarily supply us with personal information such as name, address, phone number and email address under the following circumstances:

1. When users voluntarily submit questions, comments, photos or testimonials to our Web site. We consider these items to be the property of MINES & MEADOWS and may choose to include them in our Web site, unless otherwise directed by the user at the time of their submission.
2. When users complete one of our online surveys. We occasionally use these surveys to help determine the public interest or reaction to certain activities, events, services and/or amenities at the Park.
3. When users order products through our ecommerce site. We do not capture or store our customers' payment information; that data is passed via secure connection from your computer to PayPal, which actually processes the monetary portion of the transaction. We do, however, receive the product and shipping information, in order to properly deliver the requested merchandise to our customers.

Users may from time to time supply us with personally identifiable information about other people, as in the case of referrals or gift purchases. MINES & MEADOWS does not actively market to children, and we never knowingly ask a child under 16 to divulge personal information.

Our Web server collects and compiles general statistical data that is aggregated and not personally identifiable. We use this information to determine overall site usage, number of visitors, page hits, top referring sites and search engine patterns.

We do not employ cookies. A cookie is a small text file that a Web server places on a user's computer hard drive to be a unique identifier. Cookies enable certain companies to track usage patterns and deliver customized content to users.

## **Part II. Information Usage**

If you supply us with your email address, MINES & MEADOWS may use it from time to time to notify you of such things as new services, special offers/events, or to confirm transactions. If you do not wish to be contacted by email, you may select the "unsubscribe" link at the bottom of any MINES & MEADOWS email you receive.

Additional information collected by MINES & MEADOWS will be used only for the purposes stated in Part I of this policy. If we use this information in a manner different than the purpose for which it was collected as described in this Privacy Policy, then we will ask for your consent prior to such use and provide you with an opportunity to opt out.

The information we collect will not be used to create customer profiles based on browsing or purchasing history. We will not supplement information collected at our Web site with data from other sources such as credit history to authorize purchases.

We also provide some links to third-party Web sites that are not owned by MINES & MEADOWS, including links to Google AdSense Banner Ads. MINES & MEADOWS has no control over their privacy practices and assumes no responsibility in connection with your use of their Web sites. We recommend that you check the privacy policy of any website before you provide any personally identifiable information.

### **Part III. Data Storage and Security**

MINES & MEADOWS takes appropriate security measures to protect against unauthorized access, alteration, disclosure or destruction of data. These include internal reviews of our data collection, storage and processing practices and security measures, as well as physical security measures to guard against unauthorized access to systems where we store personal data.
